
Community facilities

AT/TWO 'Plan A'

- TWO submitted to VHWHDC on 2 April 2012
- MCG Open Meeting: 24 April vote on MCG position
- Wider community split on the plan
- Users Forum: 9 May adjustments to internal plans
- VWHDC Planning meeting 19 July support, but with significant caveats and concerns
- Formation of the Joint Users Planning Group



- AT/TWO 'Plan B' October 2012
 MCG opposed several features as unsuitable
- Open meeting (16 Oct) endorsed the MCG approach proposed:
 - Review impact of latest proposals (with JUPG)
 - Review future management options
 - Continue development of community activities
 - Protect green space for the community
- New planning application submitted to VWHDC on 1 Feb 2013 and later withdrawn


























































